Upcoming U.S. Population Releases

The U.S. Census Bureau is planning to release four major sets of statistics about the U.S. population at the end of the year. The table below explains what to look for and how they are different. In 2021, the Census Bureau will release the local population counts from the 2020 Census that are used for redistricting.

¹ Additional 2020 Census results to be released in 2021 will also be used to redraw legislative districts, inform the allocation of hundreds of billions of dollars in federal funding, and provide data that affects communities for the next decade.

⁶ The overseas counts will exclude Puerto Rico. Of note, population numbers for the District of Columbia and Puerto Rico are not used for or included in the apportionment. 2020 Census results will be available below the state level in 2021.
